**RESOLUTION NO. 2019-208**

**A RESOLUTION AUTHORIZING THE DEMOLITION OF THE PNP OUTPOST LOCATED AT THE CORNER OF NICOLAS JAMILLA, SR. AVENUE ALONG STRONG REPUBLIC NAUTICAL HIGHWAY TO PREVENT OBSTRUCTION IN THE ON-GOING WIDENING PROJECT OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH)**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter dated January 9, 2019 from the Office of the Municipal Mayor requesting authority for the demolition of the PNP Outpost located at the corner of Nicolas Jamilla, Sr. Avenue along Strong Republic Nautical Highway to prevent obstruction in the on-going widening project of the Department of Public Works and Highways (DPWH);

**WHEREAS**, under Section 447 (1) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Bayan approve ordinances and pass resolutions necessary for an efficient and effective municipal government;
