





**RESOLUTION NO. 2019-216**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) REPRESENTED BY ITS UNDERSECRETARY DENIS F. VILLORENTE FOR THE IMPLEMENTATION OF THE ELECTRONIC BUSINESS PERMITS AND LICENSING SYSTEM (E-BPLS) SOFTWARE

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated January 24, 2019 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Department of Information and Communications Technology represented by its Undersecretary Denis F. Villoriente for the implementation of the Electronic Business Permits and Licensing System (E-BPLS) Software;

**WHEREAS**, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

**WHEREAS**, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, the Electronic Business Permits and Licensing System (eBPLS) being deployed by the Department of Information and Communications Technology (DICT) in collaboration with the Department of Interior and Local Government (DILG) to recognize good governance performance particularly in the adoption of good local governance;

**WHEREAS**, the Municipality of Gloria is one of the recipients of the Electronic Business Permits and Licensing System (eBPLS);

**WHEREAS**, the body finds that the said request to be of merit.


**NOW THEREFORE**, on motion of **Hon. Nicandro F. Fabon, Jr., Chairperson**, Committee on Communications and was jointly seconded by Hon. Crispin J. Bawasanta and Hon. Romeo Edward P. Alvarez, so be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Department of Information and Communications Technology represented by its Undersecretary Denis F. Villoriente for the implementation of the Electronic Business Permits and Licensing System (E-BPLS) Software, be approved.
