



**RESOLUTION NO. 2019-219**

**A RESOLUTION CONCURRENCE AND CONFIRMING THE APPOINTMENT OF ATTY. MICHAEL GALICHA CENIZA AS THE MUNICIPAL ADMINISTRATOR OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 7, 2019 requesting to pass a resolution concurring the appointment of Atty. Michael Galicha Ceniza as the Municipal Administrator of the Municipality of Gloria, Province of Oriental Mindoro;

**WHEREAS**, Section 480 of the Local Government Code of 1991 which provides, as follows:

“Section 480. Qualification, Terms, Powers and Duties. – (a) No person shall be appointed administrator unless he is a citizen of the Philippines, a resident of the local government unit concerned, of good moral character, a holder of a college degree preferably in public administration, law, or any other related course from a recognized college or university, and a first grade civil service eligible or its equivalent. He must have acquired experience in management and administration work for at least five (5) years in the case of the provincial or city administrator, and three (3) years in the case of municipal administrator.

**WHEREAS**, Section 443 (d) of the Local Government Code of 1991 provides that, the heads of departments and offices shall be appointed by the municipal mayor with the concurrence of the majority of all the sangguniang bayan members, subject to civil service law, rules and regulations. The sangguniang bayan shall act on the appointment within fifteen (15) days from the date of its submission; otherwise, the same shall be deemed confirmed;

**WHEREAS**, due to the great necessity of filling up the position, the Municipal Mayor, Hon. German D. Rodegerio appointed the only applicant Atty. Michael Galicha Ceniza as Municipal Administrator of the Municipality of Gloria, Province of Oriental Mindoro pursuant to Civil Service Laws, Rules and Regulations;



**WHEREAS**, the appointment of Atty. Michael Galicha Ceniza as the Municipal Administrator has been submitted to the Sangguniang Bayan for confirmation;

**WHEREAS**, after careful examination, scrutiny and review of the qualifications, records and experiences of Atty. Michael Galicha Ceniza, the Sangguniang Bayan finds the appointment meritorious and therefore interposes no objection to said appointment;

**WHEREAS**, this body found the appointee qualified and met the minimum requirements to the position as laid down by law.

**NOW THEREFORE**, on motion of **Hon. Lauro L. De Belen**, Chairperson, Committee on Good Government, Public Ethics and Accountability and was jointly seconded by Hon. Romeo Edward P. Alvarez and Hon. Felix V. Jarabe III, so be it.

**RESOLVED, AS IT IS HEREBY RESOLVED**, by the Sangguniang Bayan in session assembled, to confirm, as it is hereby confirms the appointment of Atty. Michael Galicha Ceniza as the Municipal Administrator of the Municipality of Gloria, Province of Oriental Mindoro.
