





**RESOLUTION NO. 2019-220**

RESOLUTION AUTHORIZING THE GLORIA INSTITUTE OF SCIENCE AND TECHNOLOGY (GIST) TO UTILIZE THE ASSESSMENT FEES DOWNLOADED AND TO BE DOWNLOADED BY TESDA TO GIST TRUST FUND ACCOUNT FOR MOTORCYCLE/SMALL ENGINE NC II, DRIVING NCII AND RAC SERVICING (DOMRAC NC II)

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor dated February 1, 2019 endorsing the letter from the Gloria Institute of Science and Technology requesting for the modification of Resolution No. 2017-149 regarding the transfer of funds from General Fund Account to Trust Fund Account;

**WHEREAS**, the power of the Sangguniang Bayan to pass and enact resolutions and ordinances includes the power to amend and revoke;

**WHEREAS**, the Assessment Fees will be utilized for the following expenses:
