RESOLUTION NO. 2019-221

A RESOLUTION AUTHORIZING ATTY. MICHAEL GALICHA CENIZA, MUNICIPAL ADMINISTRATOR TO SIGN CHECKS FOR FINANCIAL ASSISTANCE, REMITTANCES AND OTHER BANK TRANSACTION RELATED TO SALARIES OF ALL SECTIONS AND DEPARTMENTS IN BEHALF OF THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO DURING OFFICIAL AND UNOFFICIAL TRAVEL

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 11, 2019 requesting to pass a resolution authorizing Atty. Michael Galicha Ceniza, Municipal Administrator to sign checks for financial assistance, remittances and other bank transaction related to salaries of all sections and departments in behalf of the Municipal Mayor during official and unofficial travel;

WHEREAS, Hon. German D. Rodegerio in accordance with the provisions in Section 344 of the Local Government Code and in exigency of public service authorizing Municipal Administrator, Atty. Michael G. Ceniza to sign checks for financial assistance, remittances and other bank transaction related to salaries of all sections and departments in behalf of the Municipal Mayor during official and unofficial travel;

WHEREAS, as provided in Section 344 of Local Government Code, in case of temporary absence or incapacity of the department head or chief of office, the officer next-in-rank shall automatically perform his function and he shall be fully responsible therefor;

WHEREAS, the Municipal Administrator is considered the next-in-rank in the Office of the Mayor and therefore shall be responsible in administering the functions of the Local Chief Executive in case of temporary absence;

WHEREAS, the Land Bank of the Philippines requires a Sangguniang Bayan resolution naming person authorized by the Municipal Mayor to sign checks for financial assistance, remittances and other bank transaction related to salaries of all sections and departments in my behalf during official and unofficial travel;

WHEREAS, the body finds that the said request to be of merit.

NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta**, Chairperson, Committee on Finance and Appropriation and was duly seconded by all Sangguniang Bayan Members present, so be it.

RESOLVED, AS IT IS HEREBY RESOLVED that the resolution authorizing Atty. Michael Galicha Ceniza, Municipal Administrator to sign checks for financial assistance, remittances and other bank transaction related to salaries of all sections and departments in behalf of the Municipal Mayor during official and unofficial travel.


