



**RESOLUTION NO. 2019-222**

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE **LANDBANK OF THE PHILIPPINES** REPRESENTED BY ITS PRESIDENT AND CHIEF EXECUTIVE OFFICER, **ALEX V. BUENAVENTURA** THROUGH HIS DULY AUTHORIZED REPRESENTATIVE, **FERDINAND E. ABAS** FOR THE AVAILMENT OF **MOBILE-BASED SAVINGS-LINKED SALARY LOAN FACILITY** OF QUALIFIED OFFICIALS AND PERMANENT EMPLOYEES OF THE LGU

*WHEREAS*, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 11, 2019 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the **Landbank of the Philippines** represented by its President and Chief Executive Officer, **Alex V. Buenaventura** through his duly Authorized Representative, **Ferdinand E. Abas** for the availment of **Mobile-Based Savings-Linked Salary Loan Facility** of qualified officials and permanent employees of the LGU;

*WHEREAS*, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

*WHEREAS*, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, Land Bank of the Philippines offers a mobile-based savings-linked Salary Loan Facility to encourage savings and provide a loan window to qualified employees;

**WHEREAS**, Land Bank of the Philippines aims to encourage the earning group to save a portion of their monthly income for any personal purpose such as education, planned vacation, business capital, purchase of vehicle/real estate/other properties, or for future and emergency use;

**WHEREAS**, Land Bank of the Philippines has agreed to the request of the Municipality of Gloria subject to such terms and conditions as may be mutually agreed upon;

**WHEREAS**, the body finds that the said request to be of merit.


