**Supply and Delivery of Materials for the Completion of Barangay
Multi-Purpose Building – Barangay San Antonio**

1. The Municipality of Gloria, through Appropriation Ordinance No. 29 dated October 21, 2019 under the Municipal Risk Reduction and Management Office amounting to **Three Hundred Sixty-Four Thousand and Four Hundred Forty-Four Pesos (Php 364,440.00)** being the approved budget for the contract (ABC) to payments under the contract for the **Supply and Delivery of Materials for the Completion of Barangay Multi-Purpose Building-Barangay San Antonio**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Gloria now invites bids for **Supply and Delivery of Materials for the Completion of Barangay Multi-Purpose Building-Barangay San Antonio**. Delivery of Goods is required within **thirty (30) days upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. Bids must be duly received by the BAC Secretariat at the address below on or before **November 14, 2019 at 1:00 pm**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause.

Bid opening shall be on **November 14, 2019 at 3:00 pm at Municipal Conference Hall**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Municipality of Gloria** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
