AN ORDINANCE INSTITUTIONALIZING AND ADOPTING THE NATIONAL COMMUNITY DRIVEN DEVELOPMENT PROGRAM (NCDDP) IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, it is the Constitutional responsibility of the Municipal Government of Gloria to enact the policy for the empowerment of the community, people's participation, transparency, accountability, sustainable development, volunteerism, gender sensitivity, reduction of poverty and anti-corruption mechanism;

WHEREAS, theories of Kapit Bisig Laban sa Kahirapan: Comprehensive Integrated Delivery of Social Services (KALAH! CIDSS) in its 1st and 3rd cycle, the National Community Driven Development Program (NCDDP) and KC- Millenium Challenge Corporation: Incentive Grants, clearly upholds good barangay governance;

WHEREAS, adopting the KALAH!-CIDSS principles in the implementation of its programs and projects funded out from the Municipal Development Fund and/or Other Development Fund, is being considered as one of this municipality's **best practices**;

WHEREAS, The Sangguniang Bayan of Gloria passed RESOLUTION NO. 2016-49 dated September 13, 2016 entitled "A RESOLUTION ADOPTING THE KALAH!-CIDSS-NATIONAL COMMUNITY-DRIVEN DEVELOPMENT PROGRAM SPECIFIC IMPLEMENTATION ARRANGEMENTS FOR THE IMPLEMENTATION OF THE MUNICIPAL FUNDED PROJECTS."

NOW, THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Gloria, Oriental Mindoro in session assembled, that;

Section 1. Title. This Ordinance shall be known as the "Ordinance institutionalizing and adopting the National Community Driven Development Program (NCDDP) in the Municipality of Gloria, Province of Oriental Mindoro, appropriating funds, providing exemptions and for other purposes or cited as "**Municipal Community Driven Development Program Ordinance**".

Section 2. Purpose and Coverage. The purpose of this Ordinance is to uphold the Municipality of Gloria's constitutional responsibility to ensure empowerment of the community, people's participation, transparency, accountability, sustainable development, volunteerism, gender sensitivity, reduction of poverty and component of anti-corruption mechanisms.

This ordinance shall cover the twenty seven (27) barangays and its Sitios in the Municipality of Gloria, Province of Oriental Mindoro.

Section 3. Definition of terms. As used in this Ordinance, the following acronyms shall mean:


Section 54. General Provisions.

4.1 Barangay projects chargeable against the **20% Municipal Development Fund must be under the category of capital investment** and identified within the framework of the Department of Interior and Local Government (DILG) and Department of Budget and Management (DBM) Joint Memorandum Circular No. 2011-01. **The KALAHY CIDSS implementing principle is hereby adopted except in the procurement process** which is solely the responsibility of the Municipal Government of Gloria, provided that the representation of the community volunteers shall be ensured and observed.

4.2 Barangay projects chargeable against the **Other Development Fund, Public Assistance** and or other available **Municipal Government Fund may be downloaded to the community account subject to prescribed accounting and auditing rules and regulations.**

4.3 **Implementing Rules and Regulations (IRR)** of this Ordinance shall be formulated by the **Local Finance Committee, Municipal Social Welfare and Development Officer, Municipal Engineer, the President of the Liga ng mga Barangay and the Committee on Laws and Ordinances of the Sangunian, 30 days upon its approval.**

4.4 In coordination with the BSPMC, the recipient barangays must lead in the tasks and assists the functionaries for the implementation of this Ordinance.

4.5 The concerned Local Department Official shall ensure full cooperation in the implementation of this Ordinance.

4.6 Consultation with the Department of Social Welfare and Development and the Commission on Audit is hereby encouraged to ensure proper formulation of the IRR.

Section 5. Separability Clause . If for the reason any part of this ordinance shall be held unconstitutional or invalid, other parts hereof which are affected thereby shall continue to be in full force and effect.

Section 6. Repealing Clause. All ordinances, rules and regulation in conflict with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 7. Effectivity. This ordinance shall take effect upon approval of the Sangguniang Panlalawigan and after 15 days posting in the barangay hall of the twenty seven (27) barangays of Gloria.






