### MUNICIPAL ORDINANCE NO. 07 Series of 2018

Sponsored by : Hon. Romeo Edward P. Alvarez

AN ORDINANCE CREATING YOUTH DEVELOPMENT COUNCIL OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO AND FOR OTHER PURPOSES

BE IT ORDAINED BY THE MUNICIPALITY OF GLORIA PROVINCE OF ORIENTAL MINDORO, THAT:

SECTION 1. Title - This ordinance shall be known as the "Youth Development Council Ordinance of the Municipality of Gloria, Province of Oriental Mindoro"

**SECTION 2.** *Declaration of Policy* – It is declared policy of the Municipality of Gloria, Province of Oriental Mindoro to promote and protect the physical, moral, spiritual, intellectual and social well-being of Filipino Youth, inculcating in them patriotism and nationalism, and encourage their involvement in public and civic affairs.

**SECTION 3.** Definition of Terms – As used in this Ordinance, the following term shall mean:

- (1) Youth refers to those persons whose ranges from fifteen (15) to thirty (30) years old as provided under Republic Act 8044.
- (2) Youth Organizations or Youth Serving Institutions refers to duly organized and accredited Youth Organizations whose members are at least fifteen (15) but not more than Thirty (30) years old;

- a. Sangguniang Kabataan ("youth council"), commonly known as SK, is a council for youth in each barangay in the Philippines.
- b. In-School-Youth refers to youth attending either formal schools or non-school-based educational programs under institutions recognized by the State.
- c. Out-of-School-Youth refers to youth not enrolled in any formal or vocational school, not employed or self-employed, and are not college or technical/vocational school graduates.
- d. Working Youth, young entrepreneurs, young organizations - refers to youth who are either employed, selfemployed, underemployed or belong to specific employable job seeking youth groups (such as graduates of tertiary or vocational schools, or those who previously were employed and are actively looking for work) both in the formal and informal sectors of the society.
- e. Youth with Special Needs refers to youth marginalized by existing societal forces, namely: youth in indigenous cultural communities, youth with disabilities, youth in situations of armed conflict, victims of natural disasters and calamities, youth offenders, delinquent youth, drug-dependent youth, street youth, abused/exploited youth, and abandoned/neglected youth.
- f. Community-Based youth organizations (membership or programs and projects are based on a specific sitio or purok, province, city, municipality or barangay)
- g. Faith-Based youth organizations (members share a common faith, moral persuasion and spiritual beliefs with PPAs catering to the youth)
- h. Ideology-Based youth organizations (members are advancing a legitimate social ideology or thought)
- SECTION 4. Gloria Youth Development Council there shall be created a Gloria Youth Development Council which shall be responsible for the formulation of policies and implementation of youth development programs, projects and activities in coordination with various government and nongovernment organizations.
- SECTION 5. Objectives Gloria Youth Development Council shall have the following objectives.
  - General Objectives:
    - o To develop and harness the full potential of the youth as responsible partners in nation-building;
    - To encourage intensive and active participation of youth in all government and non-government programs, projects, and activities affecting them;

- To harmonize all government and non-government initiatives for the development of the youth sector; and
- To supplement government appropriations for youth promotion and development with funds from other sources,
- o To broaden and strengthen the services provided by the Local Government and its counterparts in the barangay to the youth sector.

### 2. Specific Objectives:

- To broaden and strengthen the services provided by the national government agencies, local government units and private agencies to young people;
- To provide information mechanism on youth opportunities on the areas of education, employment, livelihood, physical and mental health, capability-building and networking;
- To increase the spirit of volunteerism among the youth of the province particularly in the maintenance of peace and order and preservation, conservation and protection of the environment and natural resources within their locality;
- To provide monitoring and coordinating mechanisms for youth programs, projects and activities; and
- o To provide a venue for the active participation of the youth in cultural and eco-tourism awareness program.

**SECTION 6.** *Composition of the Council* – The council shall be composed of the following:

**SECTION 7.** Functions— The following shall be the functions of Gloria Youth Development Council:

- a) To formulate policies and component programs in coordination with the various government agencies handling youth-related programs, projects and activities;
- To coordinate and harmonize activities of all agencies and organizations in the locality who are engaged in youth development programs;
- c) To develop and provide support for the development and coordination of youth projects and design strategies to gain support and participation of the youth;
- d) To implement programs aimed in developing the full potentials of the youth;
- e) To empower the youth through heightened awareness on the various issues like early sexual encounters, teenage pregnancy, HIV and AIDS, involvement in vices and illegal drugs, bullying and abuse, gender equalities among others;
- f) To recommend youth programs and project proposals to appropriate government agencies;
- g) To accredit youth organization within the municipality;
- h) To assist the national government and government agencies, in the promotion of programs, projects and activities in the local level;
- To assist various government and non-government agencies, in the identification and nomination of qualified participants to different programs, projects and activities.
- j) To conduct fund raising programs and solicitations. It shall likewise receive donations, bequests, and may enter into contracts with other government and non-government agencies necessary for the accomplishment of the objectives of this Ordinance;
- k) To recommend youth programs and project proposals to appropriate government agencies and non-government organizations necessary for the accomplishment of the objectives of this ordinance.

- To solicit books and receive donations from any individual, non-government agencies, both local and international;
- m) To establish youth centers as deemed necessary;
- n) To monitor and submit to the Municipal Mayor the local youth agenda;
- o) To monitor implementation of programs and projects at the local level;
- p) To nominate its delegate to the National Youth Parliament; and
- q) To perform such other functions as may be provided by law.

### **SECTION 8. Functions of the Secretariat**

a. Ensure that the objectives of the Council are implemented;

- b. Decide on all matters concerning the implementation of the Youth Programs and Projects;
- c. Issue Notices of Meeting;

d. Prepare the Minutes of the Meetings;

- e. Prepare invitations to the Council Members, guests, Local Chief Executives, and other personalities;
- Provide overall coordination and direction in the operation of the council:
- g. Determine and assign matters to the appropriate council members; and
- h. Perform other functions as may be necessary.
- SECTION 9. Local Youth Development Plan The Council shall formulate and adopt a five year Municipal Youth Development Plan which shall be duly supported by an ordinance enacted by the Sangguniang Bayan. The said plan shall be basis for the implementation of the Local Youth Development programs and services in coordination with concerned agencies. These shall include but not limited to Youth Development Programs and Youth Development Services.
- SECTION 10. Youth Center The Council may establish a Youth Center which shall be located in the Municipal proper. The Youth Center shall operate as a multi-purpose center or a One-stop shop facility.
- SECTION 11. Meetings of the Council The Council shall meet at least once every three months or as often as maybe deemed necessary. The chairperson or his duly designated convenor shall preside in all council meetings.

**SECTION 12.** Appropriations – There is hereby authorized appropriations for the establishments of the Gloria Youth Development Council amounting to Three Hundred Thousand Pesos (P300, 000.00). Such amount shall be taken from the General Fund.
