AN ORDINANCE CREATING LOCAL FRANCHISING AND REGULATORY BOARD (LFRB) OF GLORIA, ORIENTAL MINDORO, DEFINING ITS POWERS, DUTIES AND FUNCTIONS

Be it ordained by the Sangguniang Bayan of Gloria, Oriental Mindoro in session duly assembled that:

Section 1. The Local Franchising and Regulatory Board (LFRB) of the Municipality of Gloria, Oriental Mindoro is hereby created to be composed of the following:

Section 2. Definition of Terms as used in this Ordinance


- a. **TMO Gloria**- refers to the Traffic Management Office of Gloria
- b. **Subpoena** - refers to a written order to appear in any proceedings of the Board
- c. Areas of operation and services- refer to areas in which the route of tricycle is provided
- d. **Tricycle for hire**- refers to motorized tricycle operated to render transport service to the general public for – a – fee
- e. **Reasonable fare rates**- tricycle fare proportional to the price of the gasoline duly consulted to the general public and to tricycle drivers and operators
- f. **Board**- refers to Local Franchising Regulatory Board

Section 3. Powers, Duties and Functions of Local Franchising Regulatory Board

- 1. Recommend to the Sangguniang Bayan
 - a. Prescription and regulation of routes and service, areas of operation and services provided by tricycle for hire in accordance with the Public Land Transportation Development Plans and Programs approved by the Department of Transportation (DOTr)
 - b. Suspension or cancellation of certificates of hired tricycles or permit and to prescribe the appropriate terms and conditions therefore.
- 2. Propose to the Sangguniang Bayan the adjustment of reasonable fare rates and other related charges related to tricycle operation provided by hired tricycle, after periodically reviewed and assessed the factors that may affect both the public and operators/drivers.
- 3. Issue subpoena and summon witness to appear in any proceedings of the Board, to administer oaths and affirmations.
- 4. Conduct investigation and hearings of complaints for violation of hired tricycle and of the Board's rules and regulations, orders, decisions and/ or ruling and to recommend the imposition of fines and/ or penalties for such violations to the Sangguniang Bayan.
- 5. Promulgate rules and regulations governing proceedings before the board and shall use all reasonable means to ascertain facts in its case speedily and objectively and without regard to technicalities of law and procedures, all in the interest of due process.
- 6. Formulate, promulgate, and administer rules and regulations on hired tricycle utilities, standard of measurements and/ or design, and rules and regulations requiring operators of any tricycle service to equip, install and provide in their stations such devices, equipment facilities and operating procedures and techniques as may promote safety, protection, comfort and convenience and property within their areas of operations.
- 7. Coordinate and cooperate with other government agencies and entities concerned with any aspect involving hired tricycle services with end view of effecting continuing improvement of such services.







8. Perform such other functions and duties as may be provided by law, as may be necessary.

Section 4. Separability Clause- If any for the reason, any part or provision of this ordinance shall be held unconstitutional or invalid, provisions not affected shall continue to be full in force and effect.

Section 5. Repealing Clause- Any ordinance or resolution or any part thereof inconsistent with this ordinance is hereby repealed or modified accordingly.

Section 6. Effectivity Clause- This ordinance shall take effect fifteen (15) days after posting in the three (3) conspicuous places of the municipality.
