MUNICIPAL ORDINANCE NO. 14
Series of 2018

Sponsored by: Hon. Nicandro F. Fabon, Jr.

AN ORDINANCE CREATING GLORIA TRAFFIC MANAGEMENT AUTHORITY AND ITS COMPONENT UNITS AND PROVIDING FUNDS THEREOF

BE IT ENACTED by the Sangguniang Bayan of Gloria, Oriental Mindoro, that:

SECTION 1. SHORT TITLE. -This Ordinance shall be known as the "GLORIA TRAFFIC MANAGEMENT AUTHORITY of 2018".

SECTION 2. Definition of Terms:

Traffic –refers to the movement of vehicles-motor-driven, man-driven or animal-drawn as well as movement of pedestrians on the streets, roadways and highways of the Municipality of Gloria.

Traffic Enforcers – uniformed civilian agents hired by the Municipality of Gloria, and duly deputized by the Local Chief Executive charged with the duty of regulating and directing traffic and implementing all Municipal Traffic Rules and Regulations.

Traffic Violator – for purposes of this Ordinance shall mean any person who violates any traffic rules and regulations of the Municipality.

Authority – as used in this Ordinance shall mean the Gloria Traffic Management Authority.

Volunteer Traffic Enforcement Group – refers to civilians who render voluntary service under the Traffic Management Authority to direct and control traffic and to assist in the enforcement of traffic laws and ordinances without remuneration.

LTO – Land Transportation Office

Deputized Agent - shall refer to the Land Transportation Office (LTO), the Philippine National Police (PNP) and the Local traffic enforcers of the Municipality of Gloria.

Citation Ticket- A ticket issued by the traffic enforcer for violating traffic rules and regulations

SECTION 3. CREATION OF THE GLORIA TRAFFIC MANAGEMENT AUTHORITY. – A special body known as Gloria Traffic Management Authority that shall manage control and oversee the implementation of the Traffic Laws and Ordinances of the Municipality of Gloria and which shall be under the Office of the Municipal Mayor, is hereby created.

SECTION 4. MEMBERSHIP. –The GLORIA TRAFFIC MANAGEMENT AUTHORITY shall be composed of the Mayor as Chairperson, the Vice-Mayor, as Vice-Chairperson, and Eleven (11) members as follows:


- a. SB Chairperson, Committee on Peace and Order
- b. SB Chairperson, Committee on Transportation and Communication
- c. Chief, Gloria Police Station
- d. Chief, Traffic Division, Gloria PNP
- e. Municipal Engineer
- f. Provincial Legal Officer
- g. Municipal Planning Development Officer
- h. Municipal Administrator
- i. Market Administrator
- j. Two members who shall be appointed by the Municipal Mayor and who shall be as follows:
 - One representative from the Education Sector
 - One representative from the Business Sector

SECTION 5. COMPONENT TRAFFIC ENFORCEMENT UNITS – The traffic enforcement units under the Traffic Management Authority shall be the following:


- a. Local Traffic Division of the Philippine National Police (PNP)
- b. Municipal Traffic Enforcers and Volunteer Traffic Enforcement Groups

SECTION 6. POWERS, DUTIES AND FUNCTIONS OF THE TRAFFIC MANAGEMENT AUTHORITY. – The primary role for the Traffic Management Authority shall supervise, manage, control and coordinate all government instrumentalities whose functions are related to the implementation and enforcement of all Municipal Traffic Laws and Ordinances, Rules and Regulations. Its powers, duties and functions are as follows:

- a. Recommend to the Local Chief Executive the hiring of Traffic Enforcers for the purpose of directing and regulating traffic, implementing and enforcing Municipal Traffic Ordinances, Rules and Regulation in order to ensure a smooth, safe and orderly flow of traffic;


- b. Supervise and control over the Traffic Enforcers and all other Law Enforcement Units that are assigned as components of the Traffic Management Authority;
- c. Monitor and evaluate the planning and implementation of traffic management plans and programs in coordination with other line agencies in the Municipality of Gloria;
- d. Review and submit to the Sangguniang Bayan for approval all traffic engineering and management schemes;
- e. Establish implementing guidelines, rules and regulations, for the implementation of the provisions of this ordinance;
- f. Conduct traffic experiments, studies and researches relative to the use of roadways, streets and highways;
- g. Perform such other related functions as may be necessary to ensure the effective planning and implementation of traffic management schemes;
- h. Organize committees among themselves as the need arises;
- i. Create and implement guidelines for the selection and hiring of Traffic Enforcers subject to the approval of the Municipal Mayor who shall have disciplinary powers over the Traffic Enforcers;
- j. Supervise and manage training and education seminars of Traffic Enforcers and to conduct regular seminars for traffic violators;
- k. The Authority may through the Local Chief Executive hire Technical personnel on contract basis as the exigencies of the service may require;
- l. Recommend to the Municipal Mayor the deputation of volunteer Traffic Enforcement Groups for traffic duty as exigency to public service may require;
- m. Perform other related functions as may be necessary to ensure the effective and proper implementation of traffic management schemes;

SECTION 7. POWERS, DUTIES AND RESPONSIBILITIES OF THE TRAFFIC ENFORCERS. – For the purpose of the proper and legal implementation and enforcement of the Municipal Traffic Laws and Ordinances, rules and regulations the traffic enforcers who shall be deputized thru an Executive Order of the Local Chief Executive as traffic enforcers shall have the following powers, duties and responsibilities:

1. Apprehend all violators of the existing Municipal Traffic Laws and Ordinances, Rules and Regulations and perform such other traffic-related duties as delegated by the Local Chief Executive and as deputized by the Land Transportation Office (LTO) to act as their deputized agents.
2. Issue Traffic Citation Tickets to the traffic violators of Municipal Ordinances, Rules and Regulations and in this case shall not confiscate his driver's license. However when duly deputized by the Land Transportation Office (LTO) the Traffic enforcer shall have the power to confiscate the driver's licenses of traffic violators of National Traffic Laws and issue to the same a temporary operator's permit issued in an accountable form by the Land Transportation Office (LTO).
3. Assist Traffic Investigation of all traffic and vehicular accidents under the supervision of the Chief of Police, Chief Traffic Division or their authorized representatives.

SECTION 8. TRAINING OF TRAFFIC ENFORCER- Traffic Management Authority in coordination with the Land Transportation Office shall conduct trainings of the traffic enforcers to provide them the necessary skills in apprehending traffic violators and also to inculcate on them the values of public relations and discipline.

SECTION 9. ESTABLISHMENT OF OFFICE. – The Traffic Management Authority shall have an office staffed with competent personnel in order to perform its functions. Funds for which shall be taken from the Office of the Municipal Mayor.


SECTION 10. FUNDING -The amount of P500, 000.00 shall be appropriated out of the funds of the municipal government to fund the operation of the Gloria Traffic Management Authority as mandated in this ordinance and which shall be included in the annual or supplemental budget of the municipal government.

SECTION 11. REPEALING CLAUSE –All other ordinances other rules and regulations or parts thereof which are inconsistent with any of the provisions of this ordinance and all other special bodies with functions related to the enforcement and implementation of the Municipal Traffic Laws and Ordinances in the municipality are hereby deemed repealed, modified or dissolved accordingly.


SECTION 12. EFFECTIVITY – This Ordinance shall take effect fifteen (15) days after posting in the three (3) conspicuous places of the municipality.
