AN ORDINANCE DECLARING EVERY 25th DAY OF SEPTEMBER OF EVERY YEAR AS "GABI NG DEPED" IN THE MUNICIPALITY OF GLORIA PROVINCE OF ORIENTAL MINDORO AND ALLOCATING FUNDS FOR IT'S CELEBRATION

WHEREAS, on the 25th day of September of every year, teachers of various school in the municipality of Gloria participated in the launching of Gabi ng DepEd with the theme "I AM A HERORESPECT, FULFILL AND PROTECT LIFE";

WHEREAS, during the celebration, the participating mentors and their schools submitted their endorsement or a draft resolution for the adoption of a Teacher's Day in the Municipality of Gloria on the 25th day of September of every year;

WHEREAS, the Municipality of Gloria is an educational center of Oriental Mindoro that promotes excellence in all aspect of life of teachers, academics, health, religion, citizenship and mental well-being;

WHEREAS, the teachers of the Municipality of Gloria are composed of more or less six hundred (600);

WHEREAS, it is desirable for the Municipality of Gloria to affirm the economic, social, educational and spiritual contributions of the teachers and to support and protect the general welfare and rights of teachers;

It is necessary to institutionalize GABI NG DEPED on the 25th day of September as part of the celebration of the Foundation Day of the municipality; and

WHEREAS, Pursuant to the observance of GABI NG DEPED, annual program of activities shall be prepared and implemented with the Municipal School Board as lead organization to be assisted by the Gloria district school supervisor, coordinators, principals, and other civic organization.

NOW THEREFORE, on motion of Hon. Lauro L. De Belen, and unanimously seconded by Hon. Nick Orlando M. Jamilla, Hon. Crispin Bawasanta, Hon. Norma R. Paz, Hon. Romeo Edward P. Alvarez, Hon. Nicandro F. Fabon, Jr., Hon. Romeo S. Sadiwa, Hon. Felix V. Jarabe, Hon. Henry S. Soberano and Hon. Bonjove S. De Mesa,

Be it ordained by the Sangguniang Bayan of Gloria in session assembled that,

Section 1. This ordinance should be known as the GABI NG DEPED in the Municipality of Gloria.

Section 2. The 25^{th} day of September of every year is hereby established and declared as GABI NG DEPED in the Municipality of Gloria.

Section 3. For the observance of GABI NG DEPED, the amount of P100,000 shall be allocated every year from the General Fund to be included in the budget of the Municipal Mayor's Office for the implementation of institutionalized activities in the Municipality of Gloria, which shall be spent in accordance with the program of activities to prepared by the GABI NG DEPED Committee to be created for the purpose, composed of representative from the Local School Board, SB Committee Chairperson on Education and representative from private and public elementary and high schools.

Section 4. Separability Clause: If for any reasons, any part of the provision of the ordinance shall be held to be unconstitutional or invalid the other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 5. Repealing Clause: All ordinances, resolutions and regulations or part or parts thereof which are inconsistent with this ordinance are hereby repealed and or modified accordingly.

Section 6. Effectivity Clause, This ordinance shall take effect in accordance with the provisions of Local Government Code of 1991.
