Invitation to Bid ITB No. 2020-002

Concreting of Brgy. Banus to Manguyang Farm to Market Road (FMR)

- 1. The Municipality of Gloria, through Local Government Support Fund (LGSF) Other Financial Assistance to LGUs amounting to Twenty Million Pesos (Php 20,000,000.00) being the approved budget for the contract (ABC) to payments under the contract for the Concreting of Brgy. Banus to Manguyang Farm to Market Road (FMR). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Municipality of Gloria now invites bids for Concreting of Brgy. Banus to Manguyang Farm to Market Road (FMR). Completion of the Works is required in Two Hundred Forty working days (240). Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instruction to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion 0as specified in the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
