RESOLUTION NO. 2018-103

A RESOLUTION CONCURRING THE APPOINTMENT OF MRS. ROSALITA M. COLOT AS MUNICIPAL GOVERNMENT DEPARTMENT HEAD AT THE OFFICE OF THE MUNICIPAL ASSESSOR, GLORIA, ORIENTAL MINDORO SUBJECT TO CIVIL SERVICE COMMISSION LAWS, RULES AND REGULATIONS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 9, 2018 requesting to pass a resolution requesting concurring the appointment of Mrs. Rosalita M. Colot as the Municipal Assessor of the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, Article 119 of IRR Appointment of Appointive Local Officials:
a) Heads of offices and departments in the LGU's shall be appointed by the Local Chief Executive concerned with the concurrence of a majority of all members of the Sanggunian, subject to civil service laws, rules and regulations;

WHEREAS, Article Three, Section 472-The Assessor Qualifications, Powers and Duties - (a) No person shall be appointed assessor unless he is a citizen of the Philippines, a resident of the LGU concerned, of good moral character, a holder of a college degree preferably in civil or mechanical engineering, commerce, or any other related course from a recognized college or university, and a first grade civil service eligible or its equivalent. He must acquire experience in the real property assessment work or in any related field for at least three (3) years in the case of the municipal assessor;

**WHEREAS**, the position of Municipal Government Department Head in the Office of the Municipal Assessor was vacated due to the retirement of Mrs. Herminia Jamilla last April 30, 2018;

WHEREAS, to fill-up subject position is deemed necessary for the Municipal Government of Gloria to support the Municipal Mayor in carrying out the duties and functions incumbent to the local government unit for the general welfare of the constituency as provided in Section 16 of the Local Government Code of 1991 (Republic Act 7160)

WHEREAS, from the documents submitted to the Office of the Sangguniang Bayan, the appointee, Mrs. Rosalita M. Colot had shown to have met the qualifications set forth in Article Three, Section 472 of Republic Act No. 7160 known as the Local Government Code of 1991:

WHEREAS, finding the said appointment to be in order after compliance with existing Civil Service Commission Laws, Rules and Regulations

NOW THEREFORE, on motion of Hon. Lauro L. De Belen, Chairperson, Committee on Good Governance, Public Ethics and Accountability duly seconded by Hon. Romeo Edward P. Alvarez, so be it.

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution concurring the appointment of Mrs. Rosalita M. Colot as Municipal Government Department Head at the Office of the Municipal Assessor, Gloria, Oriental Mindoro subject to Civil Service Commission laws, rules and regulations, be approved;
