A RESOLUTION REQUESTING SECRETARY FRANCISCO T. DUQUE III, MD OF THE DEPARTMENT OF HEALTH THROUGH OIC-REGIONAL DIRECTOR IV MARIO S. BAQUILOD, MD. MPH. CESO IV, TO AVAIL OF THE SERVICES OF "DOCTOR TO THE BARRIOS"

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 19, 2018 requesting to pass a resolution requesting Secretary Francisco T. Duque III, MD of the Department of Health through OIC-Regional Director IV Mario S. Baquilod, MD. MPH. CESO IV to avail of the services of "Doctor to the Barrios";

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, the Local Government Unit of Gloria requested the services of a "Doctor to the Barrios" to serve all the barangays of the municipality including the most inaccessible ones for the implementation of different projects that will benefit the Glorianos especially the Indigenous People;

WHEREAS, the Municipality of Gloria has signified its intent to have additional doctor to achieve the doctor-population ratio of 1:20,000 and to achieve the thrust of the municipal government to a safe, affordable and quality health services;

WHEREAS, the present Municipal Health Officer is currently serving the more or less 45,000 population which is way above the standard ratio;

WHEREAS, this august body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Nick Orlando M. Jamilla, Chairperson, Committee on Health and Sanitation duly seconded by Hon. Nicandro F. Fabon, Jr., so be it.
