A RESOLUTION APPROVING THE ACCREDITATION OF THE SAMAHAN NG MANGGAGAWANG KRISTIYANO AS NON-GOVERNMENTAL ORGANIZATION (NGO) IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 10, 2018 requesting to pass a resolution approving the accreditation of the Samahan ng Manggagawang Kristiyano represented by its President, Mr. Rexy A. Bolima as Non-Governmental Organization (NGO) in the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, Section 34 of the Local Government Code of 1991 and its Implementing Rules & Regulations provides that, to become active partners in the pursuit of local autonomy, LGUs are mandated to promote the establishment and operation of people's and non-governmental organizations;

WHEREAS, Article II, Section 23 of the Philippine Constitution provides that the state shall encourage non-government, community-based, or sectoral organizations that promote the welfare of the nation;

WHEREAS, the Local Government Unit of Gloria champions the institutionalization of NGO/PO engagement in LGU Project development, implementation, monitoring and evaluation;

WHEREAS, the Committee on Cooperatives, NGOs & POs in the Sangguniang Bayan has scrutinized the papers of the Samahan ng Manggagawang Kristiyano in order to find out whether the said NGO's qualified for accreditation and membership in the local special bodies;

WHEREAS, the Sangguniang Bayan thru the Committee on Cooperatives, NGOs & POs has approved the accreditation of the Samahan ng Manggagawang Kristiyano as accredited NGO's in the Sangguniang Bayan, after having found to have complied all necessary requirements for this purpose.

NOW THEREFORE, on motion of Hon. Nicandro F. Fabon, Jr., Chairperson, Committee on Cooperatives, NGOs & POs and was duly seconded by Hon. Romeo Edward P. Alvarez, so be

RESOLVED AS IT IS HEREBY RESOLVED, BY THE SANGGUNIANG BAYAN OF GLORIA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, in session assembled, to accredit the Samahan ng Manggagawang Kristiyano subject to all legal and existing rules and regulations.
