A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT ON THE SMALL TOWN LOTTERY (STL) SHARES OF CITY/MUNICIPALITY BY AND BETWEEN THE PHILIPPINE CHARITY SWEEPSTAKES OFFICE REPRESENTED BY ITS GENERAL MANAGER, ALEXANDER F. BALUTAN AND THE MUNICIPALITY OF GLORIA

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 13, 2018 requesting to pass a resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement on the Small Town Lottery (STL) shares of city/municipality by and between the Philippine Charity Sweepstakes Office represented by its General Manager, Alexander F. Balutan and the Municipality of Gloria;

WHEREAS, this Sanggunian finds this MOA in order, pursuant to the provisions of Section 444, Paragraph (b) (1) (vi) of Republic Act 7160, otherwise known as the Local Government Code of 1991, which authorizes the Municipal Mayor to represent the municipality in all its business transactions and sign in its behalf all bonds, contracts and obligations, and such other documents upon authority of the Sangguniang Bayan concerned pursuant to law or ordinance;

WHEREAS, under Section 40 of the revised STL Implementing Rules and Regulations (STL-IRR) which states that "The PCSO shall enter into an agreement with LGU units, agencies and offices, indicating the category of programs for which their allocation may be utilized and the reportorial requirements pertaining their utilization";

UNANIMOUSLY APPROVED.


