RESOLUTION NO. 2018-107

A RESOLUTION CONFIRMING THE NINE (9) MUNICIPAL SCHOLARS FOR CURRENT YEAR 2018-2019 OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, under Section 2 (3), Article XIV of the 1987 Constitution, the state shall maintain a system of scholarship grant, student loan programs, subsidies and other incentives, which shall be available to deserving students in both public and private schools, especially to the under privilege;

WHEREAS, Section 447 (5) (xi) of the Local Government Code of 1991 provides that the Sangguniang Bayan shall, "establish a scholarship program for the deserving students residing within the municipality in schools located within its jurisdiction";

WHEREAS, as per Section 5 of Municipal Ordinance No. 03, Series of 2014 entitled "AN ORDINANCE ESTABLISHING GLORIA MUNICIPAL SCHOLARSHIP PROGRAM (GMSP) AND APPROPRIATING FUNDS THEREFORE", provided that, the scholarship grantees under the same scholarship fund shall be subject to confirmation by the Sangguniang Bayan;
