RESOLUTION NO. 2018-109

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A RELIEF PREPOSITIONING AGREEMENT (RPA) BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE MIMAROPA REPRESENTED BY ITS REGIONAL DIRECTOR, WILMA D. NAVIAMOS, AND THE LOCAL GOVERNMENT UNIT OF GLORIA, ORIENTAL MINDORO FOR THE IMPLEMENTATION OF THE RELIEF PREPOSITIONING

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 26, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Relief Prepositioning Agreement (RPA) by and between the Department of Social Welfare and Development (DSWD) Field Office MIMAROPA and the Local Government Unit of Gloria for the implementation of the Relief Prepositioning;

WHEREAS, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, among others, provision of relief operation in times of emergencies/calamities has been devolved upon to the Local Government under Republic Act No. 7160;

WHEREAS, the DSWD through its Field Offices is mandated to provide technical and relief augmentation assistance to LGU's affected by disaster beyond its capabilities;

WHEREAS, the local government units (LGUs) thru the Municipal Social Welfare and Development Office with its available designated relief warehousing facility is willing to accommodate the prepositioned relief goods of the DSWD to be used exclusively during disasters;

WHEREAS, this body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Norma R. Paz, Chairperson, Committee on Social Services, Women, Children, Family Relation, Elderly & Indigenous People and duly seconded by all Sangguniang Bayan Members present, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to enter and sign the Relief Prepositioning Agreement (RPA) by and between the Department of Social Welfare and Development (DSWD) Field Office MIMAROPA and the Local Government Unit of Gloria for the implementation of the Relief Prepositioning, be approved.
