





RESOLUTION NO. 2018-110

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF GLORIA, ORIENTAL MINDORO AND THE NATIONAL HOUSING AUTHORITY (NHA) REPRESENTED BY ITS GENERAL MANAGER, MARCELINO P. ESCALADA, JR. FOR THE PURPOSE OF LAND DEVELOPMENT FOR THE RESETTLEMENT PROJECT OF THE MUNICIPALITY

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated July 27, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the National Housing Authority and the Municipal Government of Gloria for the purpose of land development for the resettlement project of the municipality;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, the project shall cover the Land Development of Resettlement Project in the Municipality of Gloria which is known as Gloria Po sa Amin (GPA) Homes;

WHEREAS, the project is primarily intended to provide housing assistance to benefit the urban poor families qualified for relocation and resettlement assistance under Republic Act 7279 specifically those families living in the danger areas in Gloria, Oriental Mindoro;

WHEREAS, the Municipality of Gloria agreed to pool resources for the purpose of land development for the Gloria Po sa Amin (GPA) Homes Project;

WHEREAS, this body finds that the said request to be of merit.


NOW THEREFORE, on motion of Hon. Nicandro F. Fabon, Jr., Chairperson, Committee on Rural and Urban Development and was jointly seconded by Hon. Felix V. Jarabe III, Hon. Romeo Edward P. Alvarez and Hon. Lauro L. De Belen, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the National Housing Authority and the Municipal Government of Gloria for the purpose of land development for the resettlement project of the municipality, be approved.

RESOLVED FURTHER, that copy of this resolution be furnished all concerned agencies for their information and guidance.
