RESOLUTION AMENDING SECTION 1, RULE VIII AND SECTION 5, RULE IX OF THE INTERNAL RULES OF PROCEDURE FOR THE SANGGUNIANG BAYAN OF GLORIA, ORIENTAL MINDORO

WHEREAS, the Sangguniang Bayan of Gloria, Oriental Mindoro is a legislative body duly created pursuant to law for the enactment of ordinances and adoption of resolution for the governance of the people of this municipality;

WHEREAS, pursuant to Section 50, Chapter III, Title II of Republic Act 7160, otherwise known as the Local Government Code of 1991, local Sanggunian bodies have the inherent right of adopting its own rules or procedure;


WHEREFORE, premises considered on motion of Hon. Nick Orlando M. Jamilla duly seconded by all members present during the session,

BE IT RESOLVED by the Sangguniang Bayan, this municipality to adopt the following rules of procedure to govern its deliberations.

y. Committee on Climate Change Adaptation and Disaster Risk Reduction Management - All matters pertaining to climate change and disaster risk reduction management. The committee provides legislative measures to ensure that all disaster risk reduction, climate change adaptation and related programs is included in the Municipal Annual Investment Program and to pursue the development of an integrated Provincial-Municipal Policy Framework for disaster risk management, climate change adaptation and mitigation for implementation.

Section 3. This rules of Procedure shall take effect on the date of its adoption.
