**RESOLUTION NO. 2018-115A**

**A RESOLUTION DESIGNATING HON. FELIX V. JARABE III, SANGGUNIANG BAYAN MEMBER OF THIS MUNICIPALITY TO REPRESENT THE SANGGUNIANG BAYAN IN THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPAL GOVERNMENT OF GLORIA, PROVINCE OF ORIENTAL MINDORO**

**WHEREAS**, Section 43 of RA 6975 otherwise known as the DILG Act of 1990, provided for the creation of PLEB in every city/municipality to conduct hearing and adjudication of citizens' complaints against uniformed members of the PNP for offenses committed in their area of designation;

**WHEREAS**, the Municipality of Gloria created the PLEB in order to strengthen its organization and operation pursuant to RA No. 8551;

**WHEREAS**, there is a need to designate a member of this august body to be a member of the People's Law Enforcement Board (PLEB);

**WHEREAS**, Sec. 3 Rule III of DILG MC No. 91-002 designates any member of Sangguniang Panlalawigan/Bayan chosen by the Sanggunian concerned to comprise one of the members of the PLEB;

**WHEREAS**, in compliance with the provisions of the law and to improve the necessary disciplinary actions on police forces who are committing or violating the rules and regulations while in the performance of duty there is a necessity to re-designate and/or reappoint responsible officers to compose the Board;


**NOW THEREFORE**, on motion of **Hon. Nick Orlando M. Jamilla** and was duly seconded by Hon. Romeo Edward P. Alvarez, so be it;

**RESOLVED AS IT IS HEREBY RESOLVED** that the resolution designating Hon. Felix V. Jarabe III, Sangguniang Bayan Member of this municipality to represent the Sangguniang Bayan in the People's Law Enforcement Board (PLEB) of the Municipal Government of Gloria, Province of Oriental Mindoro, be approved.
