RESOLUTION NO. 2018-118

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE DEPARTMENT OF HEALTH REGIONAL OFFICE MIMAROPA REPRESENTED BY ITS OIC-REGIONAL DIRECTOR, MARIO S. BAQUILOD, MD, MPH, CESO IV AND THE MUNICIPALITY OF GLORIA, ORIENTAL MINDORO FOR THE IMPLEMENTATION OF THE PROVINCE-WIDE MASS DRUG ADMINISTRATION ON FILARIASIS IN THE PROVINCE OF ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated August 13, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Department of Health Regional Office MIMAROPA represented by its OIC-Regional Director, Mario S. Baquilod, MD, MPH, CESO IV and the Municipality of Gloria for the implementation of the Province-Wide Mass Drug Administration on Filariasis in the Province of Oriental Mindoro;

WHEREAS, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, the province was declared as Filaria-free in 2013 after passing the first Transmission Assessment Survey (TAS) conducted in 2015, the province failed to meet the critical cut-off of cases set by the World Health Organization (WHO), hence, an Expanded TAS was conducted on May 15 to June 2, 2017 to determine the extent of the recent transmission. As a result, more cases were discovered and so another round of province-wide Mass Drug Administration (MDA) has to be implemented to ultimately eliminate the disease;

WHEREAS, DOH RO-MIMAROPA allocate the amount of FIFTY THOUSAND PESOS (P50,000.00) as sourced from the Elimination of Disease as Public Health Threat Sub-Allotment Fund (Filariasis Fund), as fund support to the Municipality of Gloria, Oriental Mindoro;

WHEREAS, this body finds that the said request to be of merit.


NOW THEREFORE, on motion of Hon. Nick Orlando M. Jamilla, Chairperson, Committee on Health and Sanitation and was seconded by Hon. Romeo Edward P. Alvarez, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to enter and sign into a Memorandum of Agreement (MOA) by and between the Department of Health Regional Office MIMAROPA represented by its OIC-Regional Director, Mario S. Baquilod, MD, MPH, CESO IV and the Municipality of Gloria for the implementation of the Province-Wide Mass Drug Administration on Filariasis in the Province of Oriental Mindoro, be approved.


