RESOLUTION NO. 2018-121

RESOLUTION APPROVING BARANGAY ORDINANCE NO. 01, S. 2018 OF BARANGAY AGOS, GLORIA, ORIENTAL MINDORO ENTITLED "ORDINANSANG NAGTATAKDA NG BUTAW BILANG KARAGDAGAN SA MGA PROBISYON NG KODIGONG PAMPAMUWISAN NG BARANGAY AGOS, GLORIA, ORIENTAL MINDORO

WHEREAS, Article III, Section 447 (1) (i) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality shall review all ordinances approved by the Sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and of the punong barangay;

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991, has devolved taxing power to Barangay to create local source of income;

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, Article IV, Section 152, (d), the barangay may levy taxes, fees and charges;

WHEREAS, Section 391, Chapter 4 of the Local Government Code of 1991 state that the Sangguniang barangay as the legislative body of the barangay shall enact tax and revenue ordinances subject to the limitations imposed on this code;

WHEREAS, said Barangay Ordinance was referred to the Committee on Laws and Ordinances which had conducted committee hearing and rendered committee report that was adopted by the honorable body;

WHEREAS, review and evaluation process confirmed that imposition of the said ordinance is within the power of the Sangguniang Barangay concerned as provided in the Local Government Code of 1991;

WHEREAS, the committee recommended to declare Barangay Ordinance No. 01 S. 2018 of Barangay Agos this municipality as non-ultra vires and consistent with law;

WHEREAS, compliance of existing laws, rules and regulations shall be the responsibility of the barangay in the implementation of said barangay ordinance.


NOW THEREFORE, on motion of Hon. Lauro L. De Belen and was jointly seconded by Hon. Henry S. Soberano and Hon. Romeo Edward P. Alvarez, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, that the resolution Approving Barangay Ordinance No. 01, S. 2018 of Barangay Agos, Gloria, Oriental Mindoro entitled "ORDINANSANG NAGTATAKDA NG BUTAW BILANG KARAGDAGAN SA MGA PROBISYON NG KODIGONG PAMPAMUWISAN NG BARANGAY AGOS, GLORIA, ORIENTAL MINDORO", be approved.
