RESOLUTION APPROVING APPROPRIATION ORDINANCE NO. 03, SERIES OF 2018 OF BARANGAY MALIGAYA, GLORIA, ORIENTAL MINDORO ENTITLED, "AN ORDINANCE AUTHORIZING THE ANNUAL BUDGET OF THE BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT FUND OF BARANGAY MALIGAYA, GLORIA, ORIENTAL MINDORO OUT FROM BARANGAY DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (BDRRMFIP) FOR CALENDAR YEAR 2018 AMOUNTING TO TWO HUNDRED SIXTY SIX THOUSAND PESOS (P266,000.00) ENTITLED FOR THE PURCHASE OF DISASTER EQUIPMENT PURPOSES.

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 was signed into law on May 27, 2010 which amends Presidential Decree No. 1566 and all other related laws, decrees, executive orders and issuances;

WHEREAS, the said law mandates the formulation and its implementation of a comprehensive and integrated barangay disaster risk reduction and management plan also known as *BDRRM* plan in accordance with the framework as prescribed under RA 10121;

WHEREAS, compliance of existing laws, rules and regulations shall be the responsibility of the barangay in the implementation of the said ordinance.

NOW THEREFORE, on motion of Hon. Lauro L. De Belen, Vice Chairperson, Committee on Finance and Appropriation and was duly seconded by Hon. Felix V. Jarabe III, so be it;
