RESOLUTION NO. 2018-126

A RESOLUTION REQUESTING HONORABLE SENATOR PAOLO BENIGNO "BAM" AQUINO IV ONE (1) UNIT OF AMBULANCE WHICH WILL BE USED BY THE MUNICIPAL HEALTH CENTER OF GLORIA, ORIENTAL MINDORO FOR THE 24-HOUR BIRTHING FACILITY SERVICES

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, the Municipality of Gloria has signified its intent to have one (1) unit of Ambulance to achieve the thrust of the municipal government to a safe, affordable and quality health services;

WHEREAS, the present ambulance is currently serving more or less 45,000 population of the municipality;

WHEREAS, due to insufficient fund of the municipality to purchase a new unit of ambulance, it urged the concerned agency to seek the benevolent support and assistance of the national government;

WHEREAS, the old ambulance of the municipality has reached its wear and tear condition and increasingly becoming difficult and unmanageable to maintain;

WHEREAS, this ambulance will be of valuable service to the general public especially on the most crucial time of distress and emergencies;

WHEREAS, this elevates the dignified mark and symbolical representation of an ambulance as a people's vehicle objectively to save and prolong life as its noble purpose;

WHEREAS, the municipality finds it difficult to fulfill its obligation and meet all the emergency situations due to limited resources.

WHEREAS, this august body finds that the said request to be of merit.


