**RESOLUTION NO. 2018-129**

**A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO AS IDENTIFIED PETITIONER TO FILE, EXECUTE AND SIGN THE PETITION AND OTHER DOCUMENTS FOR THE RECONSTITUTION OF CERTIFICATE TITLE NOS. T-59248, T-59247, T-32441 AND T-58047**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated September 10, 2018 requesting to pass a resolution authorizing the local chief executive as identified petitioner to file, executive and sign the petition and other documents for the reconstitution of Certificate Title Nos. T-59248, T-59247, T-32441 and T-58047;

**WHEREAS**, the local chief executive, Hon. German D. Rodegerio as identified petitioner is authorize to file, executive and sign the petition and other pertinent documents for the reconstitution of Certificate Title Nos. T-59248, T-59247, T-32441 and T-58047;

**WHEREAS**, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

**WHEREAS**, Section 110 of Presidential Decree No. 1529 *Reconstitution of lost or destroyed original of Torrens title*. Original copies of certificates of title lost or destroyed in the offices of Register of Deeds as well as liens and encumbrances affecting the lands covered by such titles shall be reconstituted judicially in accordance with the procedure prescribed in Republic Act No. 26 insofar as not inconsistent with this Decree. The procedure relative to administrative reconstitution of lost or destroyed certificate prescribed in said Act is hereby abrogated;

**WHEREAS**, Section 1 of Republic Act No. 26 states that Certificates of title lost or destroyed shall be reconstituted in accordance with the provisions of this act;

**WHEREAS**, this august body finds that the said request to be of merit.


**NOW THEREFORE**, on motion of Hon. Nicandro F. Fabon, Jr., Chairperson, Committee on Rural and Urban Development and was duly seconded by Hon. Crispin J. Bawasanta and all Sangguniang Bayan Members present, so be it.

**RESOLVED AS IT IS HEREBY RESOLVED**, that the resolution authorizing the local chief executive, Hon. German D. Rodegerio as identified petitioner to file, executive and sign the petition and other documents for the reconstitution of Certificate Title Nos. T-59248, T-59247, T-32441 and T-58047, be approved.
