WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated September 10, 2018 requesting to pass a resolution approving the accreditation of the Gloria Ministerial Association (GMA) as People's Organization (PO) represented by its President, Mr. Delon S. Diagsay;

WHEREAS, Gloria Ministerial Association (GMA) applied for accreditation with the Local Government of Gloria;
