WHEREAS, this matter was referred to the Committee on Laws and Ordinances and after a thorough deliberation on the matter and finding all requisites to be in order and not contrary to law and within its power to impose, it is the consensus of the Committee to approve said Barangay Ordinance;

WHEREAS, Article 111 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Panlungsod/Bayan concerned has the authority to review as to whether the ordinance is consistent with the law and city/municipal ordinances;

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, Article IV, Section 152, (d), the barangay may levy reasonable fees and charges;

WHEREAS, Section 384, Book 3, Chapter 1 of the Local Government Code of 1991 state that the barangay as basic political unit of the government is vested with legislative power to enact ordinances beneficial to its people and is in consonance to national government policies, plans and programs;

WHEREAS, Kautusang Pambarangay Blg. 01 S. 2018 of Barangay Narra will increase and improve collection of fees and charges thereby generating more funds to finance various projects, programs and activities with the barangay.

**NOW THEREFORE**, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Laws and Ordinances** and was jointly seconded by Hon. Henry S. Soberano and Hon. Lauro L. De Belen, so be it
