## RESOLUTION NO. 2018-147

A RESOLUTION ADOPTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT UPDATED CONTINGENCY PLAN FOR FLOOD, TYPHOON, EARTHQUAKE, LANDSLIDE, TSUNAMI AND STORM SURGE FOR CALENDAR YEAR 2018-2022 OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO.

WHEREAS, the local government units (LGU's) are mandated through Republic Act No. 10121 of the Philippine Disaster Risk Reduction and Management Act of 2010 to adopt and implement a coherent comprehensive, integrated, efficient and comprehensive disaster risk reduction and management program;

WHEREAS, Municipal Disaster Risk Reduction and Management Updated Contingency Plan for Flood, Typhoon, Earthquake, Landslide, Tsunami And Storm Surge for CY 2018-2022 of the Municipality of Gloria, Province of Oriental Mindoro was approved by the MDRRM Council in a meeting held on September 14, 2018;

WHEREAS, pursuant to Republic Act 10121 IRR Rule 6 Section 4 (7) the Municipal Disaster Risk Reduction Management Council in coordination with its Action Officer, is mandated to formulate and implement a comprehensive and integrated LDRRM Plan in accordance with the national, regional and provincial framework, and policies on disaster risk reduction in closed coordination with the municipal development council;

WHEREAS, it is the primary power, duty and function of the Sangguniang Bayan as the legislative body of the municipality, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, the said plan was referred to the Sangguniang Bayan Committee on Social Services, Women, Children, Family Relation, Elderly & Indigenous People for study and recommendations;

WHEREAS, a well-designed contingency plan was designed as pre-emptive measure to any kind of calamities and to ensure a maximum safety and lesser effect to life and properties;

**WHEREAS**, for the past few years, disastrous calamities had hardly hit the country resulting to loss of lives and properties and climate change contributed immensely to these effect;

WHEREAS, to reduce the risk of calamities, mitigating procedures are to be adopted, thus, the Municipality of Gloria through the Municipal Disaster Risk Reduction Management Council prepared/initiated a comprehensive contingency plans/procedures and systems;

WHEREAS, as authorized under law and in the best interest of the contingency plan of Gloria, Oriental Mindoro deems it expedient and necessary to approve the Municipal Disaster Risk Reduction and Management Updated Contingency Plan for Flood, Typhoon, Earthquake, Landslide, Tsunami and Storm Surge for Calendar Year 2018-2022 of the Municipality of Gloria, Oriental Mindoro.

**NOW THEREFORE**, on motion of Hon. Felix V. Jarabe III, Chairperson, Committee on Environmental Protection, Natural Resources and Ecology and was jointly seconded by Hon. Romeo S. Sadiwa, Hon. Henry S. Soberano and Hon. Lauro L. De Belen, it was;
