WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 1, 2018 requesting to pass a resolution approving the accreditation of the Narra Coconut Farmer's Association (NACOFA) as People's Organization (PO) represented by its President, Mrs. Cleofe M. Atienza;
