RESOLUTION NO. 2018-151

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) REPRESENTED BY MR. ELIZER S. SALILIG, REGIONAL DIRECTOR AND THE MUNICIPALITY OF GLORIA FOR THE IMPLEMENTATION OF THE FISHERY LIVELIHOOD PROJECTS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated October 22, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Bureau of Fisheries and Aquatic Resources (BFAR) represented by Mr. Elizer S. Salilig, Regional Director and the Municipality of Gloria for the implementation of the Fishery Livelihood Projects;

WHEREAS, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

WHEREAS, the Bureau of Fisheries and Aquatic Resources (BFAR) launched the Search for "Malinis at Masaganang Karagatan" to recognize outstanding initiatives and contributions of coastal municipalities/cities to sustainable fisheries development pursuant to the provisions of RA 8550: The Fisheries Code of 1998 and RA 10654: RA 8550 as Amended;

WHEREAS, the Municipal Government of Gloria is the Second Regional Winner of CY 2017 Malinis at Masaganang Karagatan (MMK) and entitled to receive One Million Pesos worth of Fishery Livelihood Projects;

WHEREAS, this body finds that the said request to be of merit.


