RESOLUTION APPROVING ORDINANCES OF BARANGAY STA. THERESA, MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO, TO WIT:

1. Kautusan Blg. 1 Serye 2018 na may pamagat na "KAUTUSANG NAGTATAKDA NG PROGRAMA NG PAGTATANIM NG MGA GULAY, PRUTAS AT HALAMANG GAMOT SA TABING KALSADA AT LIKOD BAHAY GAYUNDIN ANG PAGBABAKOD NITO SA NASASAKUPAN NG BARANGAY STA. THERESA, GLORIA, ORIENTAL MINDORO".
2. Kautusan Blg. 2 Serye 2018 na may pamagat na "KAUTUSANG NAGTATAKDA NG REGULASYON SA PAGTATAYO NG PIGGERY SA TABING CANAL, SAPA, ILOG AT DAGAT GAYUNDIN SA GITNA NG MGA BAHAYAN SA BARANGAY STA. THERESA, GLORIA, ORIENTAL MINDORO"
3. Kautusan Blg. 3 Serye 2018 na may pamagat na "KAUTUSANG NAGTATAKDA NG PAGPAPANATILI NG KAAYUSAN AT REHABILITASYON NG BEACH FOREST AT MARINE PROTECTED AREA (MPA) NG BARANGAY STA. THERESA, GLORIA, ORIENTAL MINDORO"

WHEREAS, this matter was referred to the Committee on Laws and Ordinances and after a thorough deliberation on the matter and finding all requisites to be in order and not contrary to law and within its power to impose, it is the consensus of the Committee to approve said Barangay Ordinance;

WHEREAS, Article 111 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Panlungsod/Bayan concerned has the authority to review as to whether the ordinance is consistent with the law and city/municipal ordinances;

WHEREAS, R.A. 7160 otherwise known as the Local Government Code of 1991, Article IV, Section 152, (d), the barangay may levy reasonable fees and charges;

WHEREAS, Section 384, Book III, Chapter 1 of the Local Government Code of 1991 state that the barangay as basic political unit of the government is vested with legislative power to enact ordinances beneficial to its people and is in consonance to national government policies, plans and programs;

WHEREAS, Kautusang Pambarangay Blg. 1, 2 and 3 S. 2018 of Barangay Sta. Theresa will increase and improve collection of fees and charges thereby generating more funds to finance various projects, programs and activities of the barangay.

NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Laws and Ordinances** and was jointly seconded by Hon. Romeo Edward P. Alvarez and Hon. Lauro L. De Belen, so be it

RESOLVES, AS IT IS HEREBY RESOLVED to approve Barangay Ordinance Nos. 1, 2 and 3 S. 2018 of Sta. Theresa, Gloria, Oriental Mindoro, subject to compliance with all existing laws, rules and regulations, which shall be the full responsibility of the barangay in the implementation of said ordinance.
