RESOLUTION APPROVING THE ACCREDITATION OF THE SAMAHAN SULONG SA KAUNLARAN (SSSK) AS PEOPLE'S ORGANIZATION (PO) IN THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO SUBJECT TO ALL LEGAL AND EXISTING RULES AND REGULATIONS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated October 29, 2018 requesting to pass a resolution approving the accreditation of the Samahan Sulong sa Kaunlaran (SSSK) as People's Organization (PO) represented by its President, Mr. Nagbunyan B. Kasafulo;

WHEREAS, Samahan Sulong sa Kaunlaran (SSSK) applied for accreditation with the Local Government of Gloria;

WHEREAS, Section 108 of R.A. 7160, otherwise known as the Local Government Code of 1991 provides that the authority to accredit NGOs, POs, CSOs and other similar aggrupation is vested upon the Sangguniang Bayan;

WHEREAS, the Sangguniang Bayan, after a thorough deliberation, ruled that Samahan Sulong sa Kaunlaran (SSSK) is compliant with all the requirements provided for by the Local Government Code and its Implementing Rules and Regulations and DILG Memorandum Circular No. 2016-97 dated 19 July 2016.
