RESOLUTION NO. 2018-159A

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE DEPARTMENT OF SCIENCE AND TECHNOLOGY (DOST) MIMAROPA REGIONAL OFFICE REPRESENTED BY ITS REGIONAL DIRECTOR, DR. MA. JOSEFINA P. ABILAY FOR THE IMPLEMENTATION OF THE ESTABLISHMENT OF THE PROJECT ENTITLED "ESTABLISHMENT OF COMMON SERVICE FACILITY FOR ENGINEERED BAMBOO FURNITURE AND HANDICRAFTS"

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 5, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the Municipality of Gloria and the Department of Science and Technology (DOST) MIMAROPA Regional Office represented by its Regional Director, Dr. Ma. Josefina P. Abilay for the implementation of the project entitled "Establishment of Common Service Facility for Engineered Bamboo Furniture and Handicrafts";

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, DOST-MIMAROPA has identified the project "Establishment of Common Service Facility for Engineered Bamboo Furniture and Handicrafts" of the DOST-MIMAROPA LOCAL GIA and has provided funds therefor;

WHEREAS, DOST-MIMAROPA and LGU-GLORIA pledge to extend their full cooperation for the effective and efficient implementation of the aforesaid project;

WHEREAS, DOST-MIMAROPA had identified the Local Government of Gloria as the beneficiary of the project and has sought support and assistance from DOST-MIMAROPA;

WHEREAS, the body finds that the request to be of merit.


NOW THEREFORE, on motion of **Hon. Nick Orlando M. Jamilla, Chairperson**, Committee on Tourism and was jointly seconded by Hon. Lauro L. De Belen and Hon. Romeo S. Sadiwa, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) with the Department of Science and Technology (DOST) MIMAROPA Regional Office for the implementation of the project entitled "Establishment of Common Service Facility for Engineered Bamboo Furniture and Handicrafts", be approved.
