

RESOLUTION NO. 2018-16

A RESOLUTION ADOPTING MDRRMC RESOLUTION NO. 1 SERIES OF 2018 ENTITLED, "A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT VEHICLE CRASH EXTRICATOR RESCUE EQUIPMENT AMOUNTING TO SIX HUNDRED FIFTY THOUSAND PESOS (Php650,000.00); ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW BACKHOE AMOUNTING TO ONE MILLION, SIX HUNDRED THOUSAND PESOS (Php1,600,000.00) AND ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT MAN LIFTER BUCKET TRUCK AMOUNTING TO SEVEN HUNDRED FIFTY THOUSAND PESOS (Php750,000.00) FOR THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE".

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 8, 2018 requesting to pass a resolution adopting MDRRMC Resolution No. 1 Series of 2018 entitled, "A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT VEHICLE CRASH EXTRICATOR RESCUE EQUIPMENT AMOUNTING TO SIX HUNDRED FIFTY THOUSAND PESOS (Php650,000.00); ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW BACKHOE AMOUNTING TO ONE MILLION, SIX HUNDRED THOUSAND PESOS (Php1,600,000.00) AND ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT MAN LIFTER BUCKET TRUCK AMOUNTING TO SEVEN HUNDRED FIFTY THOUSAND PESOS (Php750,000.00) FOR THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE";

WHEREAS, the procurement of backhoe would lessen the costs on clearing, digging and excavation works in disaster-prone barangays that would reduce and mitigate flood risks and would be beneficial during response and rehabilitation activities of the municipality;

WHEREAS, purchase of a Vehicle Crash Extricator Rescue Equipment would be beneficial during car accidents as it will be used by emergency rescue personnel to assist vehicle extrication of crash victims, as well as other rescues from small spaces during calamities and other accidents;

WHEREAS, purchase of a Man Lifter/Bucket Truck would provide mobility and access for people or tools/equipment to inaccessible areas, usually at height thus making it beneficial for safe and efficient trimming of trees and other disaster-related activities;

WHEREAS, the Sangguniang Bayan of Gloria determined that it is in the best interest of the municipality to purchase Backhoe, Vehicle Crash Extricator Rescue Equipment and Man Lifter/Bucket Truck for the benefits of the citizens of Gloria;

WHEREAS, the Sangguniang Bayan deems it necessary, reasonable and proper to carry out the intent purpose of the Municipal Disaster Risk Reduction and Management Council;

WHEREAS, this body finds the said request to be of merit.


NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation and duly seconded by Hon. Felix V. Jarabe III and Hon. Lauro L. De Belen, so be it.

RESOLVED AS IT IS HEREBY RESOLVED, BY THE SANGGUNIANG BAYAN OF GLORIA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, in session assembled, to adopt **MDRRMC RESOLUTION NO. 1** Series of 2018 entitled, "A RESOLUTION APPROVING THE PURCHASE OF ONE (1) UNIT VEHICLE CRASH EXTRICATOR RESCUE EQUIPMENT AMOUNTING TO SIX HUNDRED FIFTY THOUSAND PESOS (Php650,000.00); ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT BRAND NEW BACKHOE AMOUNTING TO ONE MILLION, SIX HUNDRED THOUSAND PESOS (Php1,600,000.00) AND ADDITIONAL BUDGET FOR THE PURCHASE OF ONE (1) UNIT MAN LIFTER BUCKET TRUCK AMOUNTING TO SEVEN HUNDRED FIFTY THOUSAND PESOS (Php750,000.00) FOR THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE".
