



**RESOLUTION NO. 2018-161**

**A RESOLUTION ADOPTING THE MUNICIPAL 10-YEAR SOLID WASTE MANAGEMENT PLAN (2018-2027) OF THE LOCAL GOVERNMENT UNIT OF GLORIA, PROVINCE OF ORIENTAL MINDORO.**

**WHEREAS**, presented for consideration of this august body was the Municipal 10-Year Solid Waste Management Plan (2018-2027) of the Municipality of Gloria, Province of Oriental Mindoro;

**WHEREAS**, Section 109 of RA 7160 otherwise known as the Local Government Code of 1991 (a) defines the functions of Local Development Council in formulating development plans and programs;

**WHEREAS**, it is the primary power, duty and function of the Sangguniang Bayan as the legislative body of the municipality, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

**WHEREAS**, Gloria's vision is that, ten years from now, it will be one of the model municipalities in the development, implementation, and maintenance of innovative and sustainable waste reduction, recycling and collection services, and working hand with its environmentally aware, active and responsible citizenry;

**WHEREAS**, Section 10 of the Republic Act 9003 otherwise known as Ecological Solid Waste Management Act of 2000 succinctly emphasizes the role of the local government units to be primarily responsible for the implementation and enforcement of the said act;

**WHEREAS**, the establishment of Sanitary Landfill in Barangay Agos is one of the best solutions to address the key issues the municipality is facing in the implementation of RA 9003 (Ecological Solid Waste Management Act of 2000);



**WHEREAS**, the Municipal 10- Year Solid Waste Management Plan (2018-2027) aims to demonstrate solid waste collection capabilities and disposal capacity and to continuously provide the needs concerning individual advancement contributory to the progress of the community;

**WHEREAS**, the Municipal 10-Year Solid Waste Management Plan (2018-2027) is in consonance with the National and Regional policies, goals and strategies;

**WHEREAS**, the Municipality of Gloria's environmental development goal is to ensure sustainability of economic growth and development through properly managed environment and natural resources;

**WHEREAS**, the Municipal 10-Year Solid Waste Management Plan of Gloria was conceptualized through a comprehensive review and analysis of both primary and secondary data collected for the purpose;


**WHEREAS**, the said plan was referred to the Sangguniang Bayan Committee on Environmental Protection, Natural Resources & Ecology for study and recommendations.

**WHEREFORE**, on motion of Hon. Felix V. Jarabe III, Chairperson, Committee on Environmental Protection, Natural Resources and Ecology and was duly seconded by Hon. Romeo Edward P. Alvarez, it was
