

RESOLUTION NO. 2018-162

A RESOLUTION ADOPTING THE MUNICIPAL AGRICULTURAL DEVELOPMENT AND FOOD SECURITY PLAN CY 2016-2020 OF THE LOCAL GOVERNMENT UNIT OF GLORIA, PROVINCE OF ORIENTAL MINDORO.

WHEREAS, presented for consideration of this august body was the Municipal Agricultural Development and Food Security Plan CY 2016-2020 of the Municipality of Gloria, Province of Oriental Mindoro;

WHEREAS, Section 109 of RA 7160 otherwise known as the Local Government Code of 1991 (a) defines the functions of Local Development Council in formulating development plans and programs;

WHEREAS, Art. 12, Sec. 482 (b)(2) of RA 7160 otherwise known as the Local Government Code of 1991 defines the function of the agriculturist to develop plans and strategies and upon approval thereof by the governor or mayor, as the case may be, implement the same, particularly those which have to do with agricultural programs and projects which the governor or mayor is empowered to implement and which the Sanggunian is empowered to provide for under this code;

WHEREAS, it is the primary power, duty and function of the Sangguniang Bayan as the legislative body of the municipality, to enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants pursuant to Section 16 of the Local Government Code of 1991;

WHEREAS, well-managed agricultural land provides fresh local food, food and cover for wildlife, helps control flooding, protects wetlands and watersheds, maintains air quality and has the potential to produce renewable energy and sequester carbon;

WHEREAS, the Municipal Agricultural Development and Food Security Plan CY 2016-2020 of Gloria was conceptualized through a comprehensive review and analysis of both primary and secondary data collected for the purpose;

WHEREAS, the said plan was referred to the Sangguniang Bayan Committee on Agriculture and Aquatic Resources for study and recommendations;


WHEREAS, the Committee on Agriculture and Aquatic Resources, recommended the same for approval, after consultation with Municipal Development Council (MDC).
