





**RESOLUTION NO. 2018-164**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A SPECIFIC IMPLEMENTATION ARRANGEMENT (SIA) BY AND BETWEEN THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY ITS REGIONAL DIRECTOR, WILMA D. NAVIAMOS AND THE MUNICIPALITY OF GLORIA FOR THE KALAHI CIDSS-NCDDP LGU-LED IMPLEMENTATION**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 12, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Specific Implementation Arrangement (SIA) by and between the Department of Social Welfare and Development (DSWD) represented by its Regional Director, Wilma D. Naviamos and the Municipality of Gloria for the KALAHI CIDSS-NCDDP LGU-LED implementation;

**WHEREAS**, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;

**WHEREAS**, both parties shall adhere to the roles and responsibilities contained in the Memorandum of Agreement and/or Specific Implementation Arrangement governing the implementation of GPBP and KC-MCC in the municipality;

**WHEREAS**, the partnership between the Municipality of Gloria, Province of Oriental Mindoro and the DSWD is necessary in the realization and success in the implementation of the KALAHI CIDSS-NCDDP LGU-LED;

**WHEREAS**, the DSWD, as a leader in social protection, is mandated to work towards the achievement of improved capacities and opportunities of the poor, vulnerable and disadvantaged individuals, families and communities, to enable them to improve their quality of life;

**WHEREAS**, this body finds that the said request to be of merit.

**NOW THEREFORE**, on motion of Hon. Norma R. Paz, Chairperson, Committee on Social Services, Women, Children, Family Relation, Elderly, Person with Disability & Indigenous People and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Lauro L. De Belen, so be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to enter and sign into a Specific Implementation Arrangement (SIA) by and between the Department of Social Welfare and Development (DSWD) represented by its Regional Director, Wilma D. Naviamos and the Municipality of Gloria for the KALAHI CIDSS-NCDDP LGU-LED implementation, be approved.
