**RESOLUTION NO. 2018-165**

**A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF PARTNERSHIP AGREEMENT (MOPA) BY AND BETWEEN THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, MIMAROPA REGION REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, HENRY A. ADORNADO AND THE MUNICIPALITY OF GLORIA FOR THE ADOPTION OF THE PROVINCIAL FORESHORE DEVELOPMENT AND MANAGEMENT PLAN (PFDMP) FOR THE PROVINCE OF ORIENTAL MINDORO**

**WHEREAS**, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 19, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Partnership Agreement (MOPA) for the adoption of the Provincial Foreshore Development and Management Plan (PFDMP) for the Province of Oriental Mindoro;

**WHEREAS**, Section 444 (a) (vi) of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

**WHEREAS**, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities such as social welfare services which include programs and projects on child and youth welfare, family and community welfare;



**WHEREAS**, the Provincial Foreshore Development and Management Plan (PFDMP) was formulated through the collective efforts of the Local Government Units, National Government Agencies and relevant stakeholders whom we refer to as owners and implementors of the plan;

**WHEREAS**, the Provincial Foreshore Development and Management Plan (PFDMP) was recommended by the Land Management Bureau (LMB) Planning Advisory Group and was presented to the stakeholders and was subsequently adopted;

**WHEREAS**, this body finds that the said request to be of merit.

**NOW THEREFORE**, on motion of Hon. Romeo S. Sadiwa, Vice Chairperson, Committee on Environmental Protection, Natural Resources & Ecology and was duly seconded by Hon. Romeo Edward P. Alvarez, so be it;

**RESOLVED, AS IT IS HEREBY RESOLVED**, that the resolution authorizing the local chief executive to enter and sign into a Memorandum of Partnership Agreement (MOPA) for the adoption of the Provincial Foreshore Development and Management Plan (PFDMP) for the Province of Oriental Mindoro, be approved.
