





RESOLUTION NO. 2018-17

A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE COMMUNITY BASED MONITORING SYSTEM (CBMS) NETWORK TEAM, THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT THROUGH THE BUREAU OF LOCAL GOVERNMENT DEVELOPMENT (DILG-BLGD), THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) AND THE PROVINCIAL GOVERNMENT OF ORIENTAL MINDORO (PGORM) FOR THE IMPLEMENTATION OF THE COMMUNITY BASED MONITORING SYSTEM (CBMS) SURVEY ROUND THREE

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated February 9, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement by and between the Municipality of Gloria and the Community Based Monitoring System (CBMS) Network Team, the Department of Interior and Local Government through the Bureau of Local Government Development (DILG-BLGD), the Department of Interior and Local Government (DILG) and the Provincial Government of Oriental Mindoro (PGORM) for the implementation of the Community Based Monitoring System (CBMS) Survey Round Three;

WHEREAS, under Section 17 of R.A. 7160 otherwise known as the Local Government Code of 1991 (a) Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this code and likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provision of the basic services and facilities;

WHEREAS, following Section 22 of the Local Government Code, the local chief executive may enter into contract in behalf of the local government unit provided there is prior authorization from the Sangguniang Bayan;

WHEREAS, the Community Based Monitoring System (CBMS) is an organized way of collecting information at the local level for use of local government units, national government agencies, non-government organizations and civil society for planning, program implementation and monitoring;

WHEREAS, the Community Based Monitoring System (CBMS) is a tool for improved governance and greater transparency and accountability in resource allocation;

WHEREAS, the CBMS with its disaggregated and geographically defined data has been proven as a useful tool for analyzing poverty-related issues and is deemed particularly relevant as it supports the bottom-up planning and budgeting (BUB) processes espoused by the Department that serves as basis for national government allocation priorities under the BUB program;

WHEREAS, the body finds that the request to be of merit.

NOW THEREFORE, on motion of Hon. Nick Orlando M. Jamilla and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Lauro L. De Belen, so be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Local Chief Executive to enter and sign into a Memorandum of Agreement (MOA) with the Community Based Monitoring System (CBMS) Network Team, the Department of Interior and Local Government through the Bureau of Local Government Development (DILG-BLGD), the Department of Interior and Local Government (DILG) and the Provincial Government of Oriental Mindoro (PGORM) for the implementation of the Community Based Monitoring System (CBMS) Survey Round Three, be approved.


