RESOLUTION NO. 2018-171

A RESOLUTION DECLARING OPERATIVE THE SUPPLEMENTAL BUDGET NO. 01 FOR CY 2018 OF BARANGAY G. ANTONINO APPROPRIATING THE AMOUNT OF ONE HUNDRED ONE THOUSAND NINE HUNDRED THIRTY THREE PESOS AND 30/100 (Php101,933.30.00) AND SUPPLEMENTAL BUDGET NO. 1 OF BARANGAY STA. THERESA APPROPRIATING THE AMOUNT OF ONE HUNDRED NINETEEN THOUSAND PESOS ONLY (Php119,000.00)

WHEREAS, letter dated November 16 2018 from the Municipal Budget Officer, submitted to this body, the Supplemental Budget No. 01 for CY 2018 of Barangay G. Antonino and the Supplemental Budget No. 01 for CY 2018 of Barangay Sta. Theresa, this municipality, for approval;

WHEREAS, the Supplemental Budget of Barangay G. Antonino and Barangay Sta. Theresa had been presented for review and appropriate action and after having been deliberated the said supplemental budget was found to have complied with the budgetary requirements set forth in R.A. 7160 by the Local Finance Committee;

WHEREAS, finding the papers in order, this August Body is of the consensus to approve the same;


NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation** and was jointly seconded by Hon. Lauro L. De Belen and Hon. Romeo Edward P. Alvarez, so be it;

RESOLVED AS IT IS HEREBY RESOLVED, that the resolution declaring operative the Supplemental Budget No. 01 for CY 2018 of Barangay G. Antonino appropriating the amount of One Hundred One Thousand Nine Hundred Thirty Three Pesos and 30/100 (Php101,933.30.00) and Supplemental Budget No. 1 of Barangay Sta. Theresa appropriating the amount of One Hundred Nineteen Thousand Pesos Only (Php119,000.00), be approved.


UNANIMOUSLY APPROVED.
