A RESOLUTION ENDORSING THE PROJECT ENTITLED, "PURCHASE OF MINI DUMP TRUCK" AND AFFIRMING THAT THE PROJECT IS PART OF THE DULY APPROVED 2017-2019 LOCAL DEVELOPMENT INVESTMENT PROGRAM AND THE 2018 ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 19, 2018 requesting to pass a resolution endorsing the project entitled, "Purchase of Mini Dump Truck" and affirming that the project is part of the duly approved 2017-2019 Local Development Investment Program and the 2018 Annual Investment Program;

WHEREAS, the Department of Budget and Management recently released the Local Budget Circular No. 117 dated February 5, 2018 regarding the guidelines on the release and utilization of Local Government Support Fund-Financial Assistance to Local Government Unit (LGSF-FA to LGUs) in the FY 2018 General Appropriations Act (GAA), Republic Act (RA) No. 10964;

WHEREAS, Sangguniang Bayan passed a resolution as one of the requirements for the availment of the Local Government Support Fund-Financial Assistance to Local Government Unit (LGSF-FA to LGUs) to fund the project entitled, "Purchase of Mini Dump Truck" and affirming that the project is part of the duly approved 2017-2019 Local Development Investment Program and the 2018 Annual Investment Program;

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, Section 17(3) of the Local Government Code mandates the LGU to exercise power and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective governance such as providing their constituents the basic services and facilities;

WHEREAS, after a careful study and understanding of the facts stated therein, the Sangguniang Bayan considering the noble intention of the Municipal Government of Gloria to realize the project entitled "Purchase of Mini Dump Truck" for the general welfare of the constituents;

WHEREAS, this body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Nick Orlando M. Jamilla and was jointly seconded by Hon. Crispin J. Bawasanta and Hon. Romeo Edward P. Alvarez, so be it;
