





RESOLUTION NO. 2018-178

A RESOLUTION DECLARING OPERATIVE IN PART SUPPLEMENTAL BUDGET NO.01 S. 2018 OF BARANGAY STA. MARIA AMOUNTING TO TWO HUNDRED SEVENTY EIGHT THOUSAND THREE HUNDRED EIGHTY FIVE PESOS AND EIGHTY CENTAVOS (P278,385.80) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 01 DATED NOVEMBER 7, 2018

WHEREAS, letter dated November 23, 2018 from the Municipal Budget Officer, submitted to this body, the Supplemental Budget No. 01 for CY 2018 of Barangay Sta. Maria, for approval;

WHEREAS, the Supplemental Budget No. 01 of Barangay Sta. Maria came from their Surplus for Fiscal Year 2017 amounting to Two Hundred Seventy Eight Thousand Three Hundred Eighty Five Pesos and Eighty Centavos (P278,385.80);

WHEREAS, the remaining P.S Funds of Barangay Sta. Maria is only Thirteen Thousand Six Hundred Four Pesos and 01/100 (P13,604.01), thus the said Barangay will exceed their 55% P.S. Limitation;

WHEREAS, Sangguniang Barangay is recommended to act an amendatory ordinance amending Item No 1 of Supplemental Budget No. 1-Appropriation Ordinance No. 01 allocating the amount of Thirteen Thousand Six Hundred Four Pesos and 01/100 (P13,604.01) for their Year End Bonus while the remaining allocation amounting to Fifty Nine Thousand Eight Hundred Ninety Five Pesos and 99/100 (P59,895.99) can be allocated for MOOE or Capital Outlay;

WHEREAS, the Sangguniang Barangay shall follow the existing rules and regulations as stated in the Local Government Code of 1991, Barangay Budget Operations Manual and Local Budget Memorandum No. 29, dated May 15, 1998;

NOW THEREFORE, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation** and was jointly seconded by Hon. Henry S. Soberano, Hon. Felix V. Jarabe III and Hon. Norma R. Paz, so be it;

RESOLVED AS IT IS HEREBY RESOLVED, that the resolution declaring operative in part the Supplemental Budget No.01 S. 2018 of Barangay Sta. Maria amounting to Two Hundred Seventy Eight Thousand Three Hundred Eighty Five Pesos and 80/100 (P278,385.80) passed under Sangguniang Barangay Appropriation Ordinance No. 01 dated November 7, 2018, be approved.
