

**WHEREAS**, DepEd designed the implementation of Enhanced Basic Education Act of 2013 within the framework of increased community involvement in the learner's experience;

**WHEREAS**, The Department of Education (DepEd) issued DO No. 30. S. of 2017 regarding the **Guidelines for Work Immersion** as basis for the implementation of work immersion in all Senior High Schools (SHSs);



**WHEREAS**, Work Immersion is a key feature of the SHS Curriculum. It can be conducted in different ways depending on the purposes and needs of learners;

**WHEREAS**, the objective of Work Immersion Partnership is to supplement the formal curriculum of the SHS student program with special inputs coming from the AGENCY experts and practitioners in order to make the SHS student program aligned and consistent with work standards;

**WHEREAS**, the schools had submitted list of students to the Office of the Municipal Mayor. Schedule of students is already prepared including their designated offices;

**WHEREAS**, WIP will start on December 5, 2018 with one day orientation to be given by their respective school principal and WIP coordinator;

**WHEREAS**, the body finds that the request to be of merit.
