





A RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE, HON. GERMAN D. RODEGERIO TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE MUNICIPALITY OF GLORIA AND THE ERHARD SCIENCE AND TECHNOLOGY INSTITUTE (ESTI) REPRESENTED BY ITS ADMINISTRATOR, MRS. CECILIA F. YUMANG FOR THE IMPLEMENTATION OF THE ON THE JOB TRAINING OF 4TH YEAR BACHELOR OF SCIENCE IN TOURISM MANAGEMENT STUDENTS

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated November 19, 2018 requesting to pass a resolution authorizing the local chief executive to enter and sign into a Memorandum of Agreement (MOA) by and between the Municipality of Gloria and the Erhard Science and Technology Institute (ESTI) represented by its Administrator, Mrs. Cecilia F. Yumang for the implementation of the on the Job Training of 4th year Bachelor of Science in Tourism Management students;


