**WHEREAS**, this matter was referred to the Committee on Laws and Ordinances and after a thorough deliberation on the matter and finding all requisites to be in order and not contrary to law and within its power to impose, it is the consensus of the Committee to approve said Barangay Ordinance;

**WHEREAS**, Article 111 of R.A. 7160 otherwise known as the Local Government Code of 1991 states that the Sangguniang Panlungsod/Bayan concerned has the authority to review as to whether the ordinance is consistent with the law and city/municipal ordinances;

**WHEREAS**, R.A. 7160 otherwise known as the Local Government Code of 1991, Article IV, Section 152, (d), the barangay may levy reasonable fees and charges;

**WHEREAS**, the Committee on Laws and Ordinances, of this august body conducted initial review and evaluation on the documents submitted and found out that the same is in order and enacted within the conferred powers of the Barangay pursuant to paragraph (a) item 1 Art. 101 of the Rules and Regulations Implementing the R.A. 7160 otherwise known as the Local Government Code of 1991;

**NOW THEREFORE**, on motion of **Hon. Crispin J. Bawasanta, Chairperson, Committee on Laws and Ordinances** and was jointly seconded by Hon. Felix V. Jarabe III and Hon. Henry S. Soberano, so be it

**RESOLVED, AS IT IS HEREBY RESOLVED** to approve Barangay Ordinances of Barangay Lucio Laurel, Municipality of Gloria, Province of Oriental Mindoro, be approved.

**RESOLVED FURTHER**, that copy of this resolution be furnished the Office of the Municipal Mayor, Office of the Municipal Treasurer, Office of the Municipal Local Government Operation Officer, the Gloria Municipal Police Station and the Sangguniang Barangay of Lucio Laurel, all of Gloria, Province of Oriental Mindoro for their information and guidance.
