## **RESOLUTION NO. 2018-185**

A RESOLUTION APPROVING THE 2018 SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF GLORIA, PROVINCE OF ORIENTAL MINDORO
