RESOLUTION NO. 2018-186

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO UTILIZE THE AMOUNT OF ONE MILLION PESOS (Php1,000,000.00) APPROPRIATED FOR THE PROJECT ENTITLED "INVESTMENT PROPERTY LAND FOR MULTI-PURPOSE BUILDING LUCIO LAUREL CENTRO" ALLOCATED IN THE APPROVED SUPPLEMENTAL BUDGET NO. 01 DATED APRIL 10, 2018, APPROPRIATION ORDINANCE NO. 02 UNDER THE GENERAL FUND OF THE MUNICIPAL ENGINEERING OFFICE

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated December 7, 2018 requesting to pass a resolution authorizing him to utilize the amount of One Million Pesos (Php1,000,000.00) appropriated for the project entitled "INVESTMENT PROPERTY LAND FOR MULTI-PURPOSE BUILDING LUCIO LAUREL CENTRO";

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, Section 17(3) of the Local Government Code mandates the LGU to exercise power and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective governance such as providing their constituents the basic services and facilities;

WHEREAS, the Local Finance Council issued a certification dated December 7, 2018 certifying that the amount of One Million Pesos for the project entitled "Investment Property Land for Multi-Purpose Building Lucio Laurel Centro" has been appropriated, available and allocated in the approved Supplemental Budget No. 01 dated April 10, 2018, Appropriation Ordinance No. 02 under the General Fund of the Municipal Engineering Office;

WHEREAS, after a careful study and understanding of the facts stated therein, the Sangguniang Bayan considering the noble intention of the Municipal Government of Gloria to realize the project entitled "Investment Property Land for Multi-Purpose Building Lucio Laurel Centro" for the general welfare of the constituents of Barangay Lucio Laurel;

WHEREAS, this body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation and was duly seconded by Hon. Romeo Edward P. Alvarez, so be it;

RESOLVED, AS IS IT HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D.
