



RESOLUTION NO. 2018-187

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. GERMAN D. RODEGERIO TO PROCURE ONE (1) UNIT OF MOTOR VEHICLE AMOUNTING TO FOUR HUNDRED SEVENTY FIVE THOUSAND PESOS ONLY (Php475,000.00) TO BE UTILIZED IN GLORIA INSTITUTE OF SCIENCE AND TECHNOLOGY (GIST)

WHEREAS, received by the Sangguniang Bayan for appropriate action is the letter from the Municipal Mayor, Hon. German D. Rodegerio dated December 7, 2018 requesting to pass a resolution authorizing him to procure one (1) unit of Motor Vehicle amounting to Four Hundred Seventy Five Thousand Pesos Only (Php475,000.00) to be utilized in Gloria Institute Of Science And Technology (GIST);

WHEREAS, Art. 3, Sec. 447 of the Local Government Code of 1991 states that the Sangguniang Bayan as the legislative body of the municipality, shall enact ordinances, approve resolutions and appropriate funds for the general welfare of the municipality and its inhabitants;

WHEREAS, Section 17(3) of the Local Government Code mandates the LGU to exercise power and discharge such other functions and responsibilities as are necessary, appropriate or incidental to efficient and effective governance such as providing their constituents the basic services and facilities;

WHEREAS, the procurement of one (1) unit of Motor Vehicle amounting to Four Hundred Seventy Five Thousand Pesos Only (Php475,000.00) to be utilized in Gloria Institute Of Science And Technology (GIST) as part of grant from DOLE under the Bottom-Up Budgeting (BuB) Program for the procurement of standard tools, materials and equipment for HVAC/R Programs (DOMRAC Servicing NC II and Transport RAC Servicing NC II) and Motorcycle/Small Engine Servicing NC II, all within the prescribed limitations set forth under the Budget Circular 2010-2 dated March 10, 2010 of the Department of Budget and Management;

WHEREAS, after a careful study and understanding of the facts stated therein, the Sangguniang Bayan considering the noble intention of the Municipal Government of Gloria to procure one (1) unit of Motor Vehicle amounting to Four Hundred Seventy Five Thousand Pesos Only (Php475,000.00) to be utilized in Gloria Institute of Science and Technology (GIST);

WHEREAS, this body finds that the said request to be of merit.

NOW THEREFORE, on motion of Hon. Crispin J. Bawasanta, Chairperson, Committee on Finance and Appropriation and was jointly seconded by Hon. Nicandro F. Fabon, Jr. and Hon. Felix V. Jarabe III, so be it;

RESOLVED, AS IS IT HEREBY RESOLVED, that the resolution authorizing the Municipal Mayor, Hon. German D. Rodegerio to procure one (1) unit of Motor Vehicle amounting to Four Hundred Seventy Five Thousand Pesos Only (Php475,000.00) to be utilized in Gloria Institute of Science and Technology (GIST), be approved.
